PARKING LOT REPAIR AT CASA GUADALUPANA

Work will begin on repairing the parking lot at Casa Guadalupe on Thursday, June 21. It will take two days to remove the existing blacktop, remove the existing compact material, replace with a new subsurface, and grade the area. An attempt will be made to lower the incline of the hill onto Hall Ave.

Then, on Monday, June 25, post holes will be dug and posts set for a privacy fence on the north and west boundary of the property. After a few days for the concrete to cure, the fence will be installed.

Then, a blacktop company will return to lay and stripe the surface of the driveway and parking lot. Parking stripes will run at an angle to enable more cars to park when needed for church events.

Overall, the process is schedule to take 2-3 weeks and hopefully done by the second week of July. A lot blessing will take place upon completion.
