## VOLUNTEER SPOTLIGHT



**TIM NOWAK** – Our family joined the parish prior to our oldest son Jason starting grade school at St. Matthew's. Our 4 children all attended the parish school and as a result, we have been involved with the school. I have been an active member of the St. Matthew's Men's Club in various leadership capacities and am the Fish Fry coordinator. I have served on the parish council and have been chairman and volunteer at many parish festivals. I am an Air Force veteran, a graduate of the Univ. of Minnesota and retired from Unisys in 2014. I was a business owner in W. St. Paul for 21 years. I continue to work as the Gambling Manager for the So. Robert Business Assn. As the Gambling Manager, I oversee operations at 15 pull tab sites. The profits generated from these sites enabled the Business Assn to donate \$200,000.00 in our local communities in 2017. The St. Matthew's Men's Club runs the meat raffles at Gallagher's Bar every Fri. at 5pm and received almost \$6000 in 2017 which is used in support of the parish and Community of Saints School.

In 1994 I had been looking for a way to raise money for the parish and discovered a program called **Scrip**! I presented it to the parish with a commitment to get it up and running. In Oct 1994 the St. Matthew's Scrip Program began, with \$5200 in funding from the parish. How does this work? We purchase gift cards from a distributor, Great Lakes Scrip, at a discount and sell them at face value. Example: One \$100 or four \$25 Cub, Super America or Holiday cards costs us \$96. When the cards are purchased we make \$4 on the purchase. It doesn't sound like much but if 100 families did this every month, we would profit \$400! Need a tax deduction? The discounted amount is deductible on your taxes! Scrip can also be purchased on-line. Great Lakes Scrip has a program called **Scrip Now** where you can purchase on-line and print a certificate from your computer or you can reload a current gift card. Donations to the parish through 2018 have totaled over \$38,000!! There are gift cards for 60+ retailers. Tim sells Scrip after every weekend Mass. It isn't too soon to begin your holiday shopping and help support the parish at the same time!

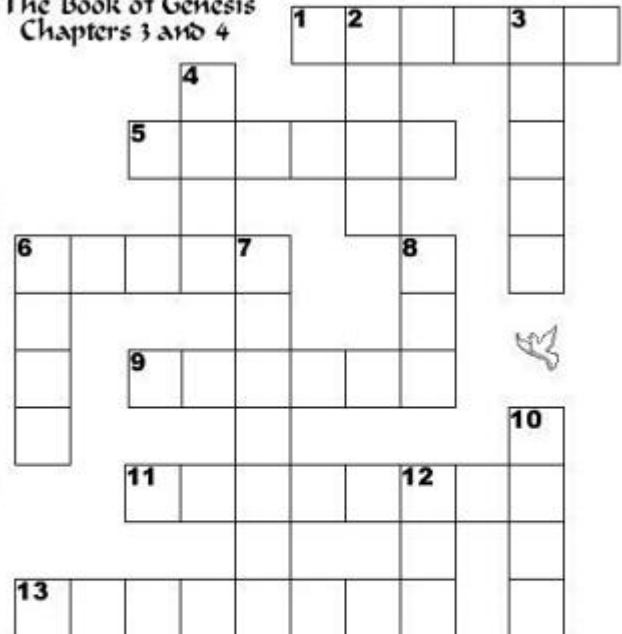
